Please kindly read carefully:

1. We advise you to take public transport to Tai Tam Country Park (near Hong Kong Parkview) as there is no parking space nearby.
 - Take City Bus number 6, 41A, 76 or New Bus number 63, 66 and get off at Wong Nai Chung Reservoir Park (please see attached photo 1).
 - Then walk uphill on Tai Tam Reservoir Road for around 15 minutes to Hong Kong Parkview and look for the entrance gate of Tai Tam Country Park (please see attached photo 2).
2. **We will start the walk promptly at 10:00am.**
3. It takes around 2.5 hours to finish the walk. Please note we need to walk uphill, downhill and some stairs. Please bring your own water.
4. We will have refreshment together at the end of the walk in the Morning Walkers' Garden of Quarry Bay. There will be volunteers there letting you know where is the picnic area.
5. Please note that there is one toilet near the assemble point and one toilet near the picnic area.
6. If you are going to walk with your family or friends, you just need to complete **ONE** Enrolment Form and please specify how many people will walk with you as we need to make the necessary arrangement for the refreshment.
